## CONTRACT

### OUR DUTIES:

- \*  Determine best selling strategy (auction, or fixed price)
- \*  Take professional looking digital pictures
- \*  Write complete descriptions and title with keyword searches in mind
- \*  Determine the best day and time to list your item(s) for eBay auction
- \*  Determine the best starting bid or fixed price
- \*  Determine how long your item(s) should be on auction (1, 3, 5, 7, or 10 days). If fixed price, 90 day listing max
- \*  Upgrade the eBay basic listing if deemed beneficial
- \*  Post and manage your item(s) on eBay
- \*  Notify you when your item will go on eBay, if provided with an email address
- \*  Respond to all inquiries and questions regarding your item(s)
- \*  Electronically invoice buyers
- \*  Payment processing
- \*  Professional packing of item(s)
- \*  Ship item(s) to winning bidder(s)
- \*  Send you a check for your paid sold item(s) within 10 days after buyer has received item(s). Should item(s) not be as described by owner/seller and if any monies are refunded to the buyer, seller s proceeds will be reduced accordingly.

### FEES:

- \*  60% (minimum of \$10.00) of selling price from \$0.01 to \$74.94 (40% to Consignor)
- \*  40% of selling price from \$74.95 to \$999.94 (60% to Consignor)
- \*  38% of selling price from \$999.95 to \$2,999.94 (62% to Consignor)
- \*  35% of selling price from \$2,999.95 to \$4,999.94 (65% to Consignor)
- \*  30% of selling price from \$4,999.95 and higher (70% to Consignor)

The above percentages include any applicable listing and selling fees. Shipping fees are paid by the buyer. If shipping is free, shipping costs are deducted from selling price prior to split.

If your item is a lot set or collection of anything that needs inspecting for quality and/or making sure items are in their proper container, an up front inspection fee of \$10 will be charged for up to 50 items. The up front fee is negotiable for any set or collection over 50 items. This fee is non-refundable.

If your item is a lot set of breakables such as dishes or heavy electronics or is big and bulky, there will be a \$10 packing fee deducted from your proceeds. May be more if several boxes are needed to pack item(s) properly.

We do not put reserves on our auctions as eBayers dislike them. There will be an up front fee charge of \$10 plus 1% of the reserve amount per item if you wish to put a reserve on any of your items. Should you wish us to have the starting bid higher than what we determined it should be, there will also be an up front \$15 per item fee charged. Should these items sell, any up front fees, not including the non-refundable 1%

eBay fee, will be refunded to you with your check.

If we have determined that your item is not eBayable and you are signing this agreement, a fee of \$10-\$25 per item will be paid up front to cover our costs. The amount is determined based on how much work is needed to list your item properly as well as the dollar amount of the starting price. Should the item sell, any up front fees will be refunded to you with your check.

We reserve the right to sell your items outside of eBay if we have determined that it will be beneficial to all parties involved. You will still receive the same percentage of proceeds as outlined above.

We are not responsible for what the final sales price is. Should your item(s) not sell on eBay auction, you have the following options.

- 1.) Relist your item(s) on eBay with us with an up front fee of \$10. This fee will be refunded to you with your check should your item sell on the 2<sup>nd</sup> go around.
- 2.) Pick up your item(s) within 7 calendar days from the time we contact you that your item did not sell. If any unsold items are not picked up within the 7 calendar days, we will dispose of your items as we see fit.

Seller agrees that the item(s) are as described by Owner and in working order if mechanical or electrical. Should they not be, then Seller shall pay all listing fees and damages, if any, to Internet Guy Enterprises prior to receiving their item(s) back should they not sell. If not paid within 7 days of notification, item(s) shall become property of Internet Guy Enterprises to dispose of as they see fit. If they should sell, the additional eBay fees, if any, will be deducted from Seller's proceeds.

The Seller of the items being listed and consigned with us, which are listed on the third page of this contract or on a separate piece of paper, understand that these items will be left with Internet Guy Enterprises through the eBay process. They further agree that they no longer have the right to sell or give away these items to anyone unless they did not sell and have been picked up by the Seller. The Seller also stipulates that they are the rightful owners to these items and holds Internet Guy Enterprises harmless should sellers not have the authorization to sell these items.

Checks will be made payable to and will be sent only to the party signing this agreement.

This is a legally binding contract.
